## Synopsis

In light of industry and company safety performance trends and direct incident outcomes, in October 2022 SPA decided to embark on a comprehensive review of our safety performance and the underlying contributing factors, with the intent of implementing systematic change where required. The project was initiated by establishing a project steering group comprising our Safety Manager and General Management, thus ensuring the group had suitable authority to make and implement decisions. The Executive General Manager was assigned as project manager to ensure the company maximized the level of commitment.

Key elements of the project plan and outcomes included the following:

- Detailed consultation sessions with sample representatives of all business units and all roles within our business. Consultation sessions were warts and all sessions that focused on good and underperforming elements of safety
- A comprehensive review of the information obtained from initial consultation, and evaluation of common gaps and improvement areas contributing to performance
- Identification of four key target areas that would enable change and that we would have the ability to implement in a reasonable timeframe. These included:
  - Effective Daily Prestarts
  - Onboarding and successful starts training
  - People and accountability
  - Safety system improvements
  - Each key target area was provided a project manager who embarked on identifying targeted improvement strategies

Throughout the project to date, a key element has been the communication and consultation throughout all levels of the business to ensure adequate awareness, generate genuine project 'buy in' and maximise our opportunity to enable input from all staff.

The project has now implemented two of the initial key elements in onboarding and successful starts training, along with people and accountability.

Effective daily prestarts is nearing completion of trail phase and set for implementation late June 2023.

We are starting to measure performance outcome changes to validate the success of initial improvements, and the project steering group has commenced evaluating phase two improvement opportunities.






